Take care floor surface will be slippery at site of spillage	
Small spill	Dilute with water (to prevent dusting) and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container
Large spill	Keep away from heat. Keep away from sources of ignition. Adsorb with dry earth into sewers, basements or confined areas
Wear chemical safety goggles, splash suit, rubber boots and gloves. Adsorb onto adsorbent paper. Prevent spillage from entering drains. Do not touch spilled material. Place in a bag/other appropriate non-hazardous container and hold away from ignition sources/hear for waste disposal. Ventilate area and wash spill site water after material pickup is complete.

Steps to be taken in the event of spillage or chemical release – waste disposal method: Dispose of in accordance with national and local regulations for inert non- hazardous waste material.

Precautions to be taken in Handling and storage: Store in a cool, dry place (13 deg C/ 35 deg C) in original sealed containers away from heat sources and sunlight. Avoid contact with strong oxidants and strong acids.
